## General Payment and Refund Policy

### Payments:

- 1) Payment may be made in cash, VISA, Mastercard, AMX, Diners Card, E-transfer, or by cheque, unless otherwise stipulated.
- 2) There will be a \$30.00 service charge for a dishonored cheque and it will be considered as a payment not made and appropriate missed deadline penalties may be imposed.
- 3) All deposits are non-refundable unless otherwise stated. Check with our web site and/or the event coordinator
- 4) Telephone or e-mail reservations will be considered as a booking on the date made and may incur immediate deposit obligations and must be followed up by actual payments.
- 5) Postdated cheques may be required for the balance of the payment at time of booking.

### Refunds:

- 1) Refunds less the non-refundable deposit will be granted as follows:
  - a) The event coordinator is notified a minimum of two weeks before the event or activity. Special trips may require even more notice.
  - b) There is a death or serious illness in the immediate family
  - c) The member falls seriously ill or suffers an injury serious enough that would prevent their participation
- 2) If no loss to the club, refunds will be by cheque or e-transfer. If it creates a loss, a PSC credit voucher will be issued which can be applied to all Pacific Ski Club tours, events, memberships, etc., and is good for one year.
- 3) If a participant finds their own replacement, credit that compatible member will pay the original participant directly.
- 4) Not showing up for an event or poor weather conditions do NOT constitute an adequate reason for a refund and do not release a member from their obligations to the club for payment.

## Obligation of Membership and Waiver of Liability

As a member of the Pacific Ski Club, I hereby agree to abide by the above rules, the Constitution, By-laws, and regulations as set forth from time to time by the Executive. I further agree not to hold the Pacific Ski Club, its Executive, or Membership responsible for any personal injury or loss while attending any function, event or tour sponsored by the Pacific Ski Club, or for any expenses incurred while in attendance at functions/ events organized by the Pacific Ski Club, when circumstances not governable by the Pacific Ski Club are responsible for that expense.
